These fees are usually termed shipping preparation, shipping tank rental, and actual shipping charges to ship the semen to its destination and for the return of our empty tank.

Sperm cells will eventually cease living, but no one knows or can predict when this will occur, and it can vary from dog to dog. ICSB Atlanta shall not be held liable for, and cannot guarantee conception from, frozen canine semen. Nor can ICSB Atlanta guarantee that the frozen sperm cells will be viable at the time of thawing for insemination. ICSB Atlanta does not make any representation nor warranty regarding the result from treatment, artificial insemination and /or the use and viability of frozen semen. Morphology and post thaw results may vary depending on thaw methodology and analyzation techniques.

ICSB Atlanta makes no representation and extends no warranty of any kind, either express or implied, with respect to the collection, storage or shipment of semen, results from treatment, artificial insemination and/or the use and viability of frozen semen. Signatory agrees that ICSB Atlanta and its affiliates shall not be liable for, and is not responsible in any way, any accident, damage or loss of semen once semen is in the hands of any shipping carrier or other persons involved in transporting semen. Owner/Recipients of semen agrees to insure all shipments and immediately inspect such shipments on arrival to validate such claims.

Semen Recipient shall not hold ICSB Atlanta, their directions, officers, agents and employees harmless from any and all liability, damage, loss, or cost or expense (including, without limitation, reasonable attorney's fees, and expenses resulting from any claims or suits brought against ICSB Atlanta. Semen Recipient agrees that all questions concerning the validity, interpretation and enforcement of this Agreement shall be determined by arbitration conducted in Cherokee County, GA in accordance with the Commercial Dispute Resolution Procedures of the American Arbitration Association (AAA) before single neutral arbitrator chosen by AAA. The decision of the arbitrator shall be final and binding on both parties, and neither party shall have a right to appeal nor to judicial review. A judgment on the arbitrator's decision may be entered by any court having jurisdiction over the parties. In connection with such proceeding, the substantially prevailing party shall be entitled to receive its expenses (including reasonable attorneys' fees) from the substantially non-prevailing party. This agreement to resolve any disputes by binding arbitration shall extend to claims against any parent, subsidiary or affiliate of each party, and when acting within such capacity, any officer, director, shareholder, employee or agent of each party, or any of the above, and shall apply as well as claims arising out of state and federal statutes and local ordinances as well as to claims arising under the common law.
